## Committee on Health, Insurance, & Environment.

## HB16-1438 be amended as follows:

- 1 Amend printed bill, page 4, strike lines 2 and 3 and substitute "EMPLOYEE
- 2 HAS NOT REQUESTED OR AN ACCOMMODATION THAT IS".
- 3 Page 4, line 14, strike "THE EMPLOYER" and substitute "IF AN APPLICANT
- 4 OR AN EMPLOYEE REQUESTS AN ACCOMMODATION, THE EMPLOYER AND
- 5 APPLICANT OR EMPLOYEE".
- 6 Page 4, line 15, strike "WITH THE EMPLOYEE".
- 7 Page 4, line 16, before "EMPLOYEE" insert "APPLICANT OR".
- 8 Page 5, strike line 20 and substitute:
- 9 "(III) CREATE A NEW POSITION, INCLUDING A LIGHT DUTY POSITION
- 10 FOR THE EMPLOYEE, UNLESS A LIGHT DUTY POSITION WOULD BE PROVIDED
- 11 FOR ANOTHER EQUIVALENT EMPLOYEE; OR".
- Page 6, line 13, strike "PARAGRAPH (b) OF".
- 13 Page 6, line 15, after "(6)", insert "(a)".
- 14 Page 6, after line 17 insert:
- 15 "(b) This section neither increases nor decreases an 16 EMPLOYEE'S RIGHTS, UNDER ANY OTHER LAW, TO PAID OR UNPAID LEAVE
- 17 IN CONNECTION WITH THE EMPLOYEE'S PREGNANCY.
- 18 (7) NOTWITHSTANDING SECTION 24-34-405, A COURT SHALL NOT
- 19 AWARD PUNITIVE DAMAGES IN A CIVIL ACTION INVOLVING A CLAIM OF
- 20 FAILURE TO MAKE A REASONABLE ACCOMMODATION FOR AN EMPLOYEE
- 21 FOR CONDITIONS RELATED TO PREGNANCY OR THE PHYSICAL RECOVERY
- 22 FROM CHILDBIRTH IF THE DEFENDANT DEMONSTRATES GOOD-FAITH
- 23 EFFORTS TO IDENTIFY AND MAKE A REASONABLE ACCOMMODATION THAT
- 24 WOULD PROVIDE AN EMPLOYEE WHO HAS A HEALTH CONDITION RELATED
- 25 TO PREGNANCY OR THE PHYSICAL RECOVERY FROM CHILDBIRTH WITH AN
- 26 EQUALLY EFFECTIVE OPPORTUNITY AND WOULD NOT CAUSE AN UNDUE
- 27 HARDSHIP ON THE OPERATION OF THE DEFENDANT'S BUSINESS.".
